### COMPLETION OF RIGHTS OFFER

Further to the ASX Announcement dated 8 October 2020, Mustera Property Group Ltd (**Mustera** or **Company**) is pleased to confirm that it has completed the 1-for-6 non-renounceable rights issue of fully paid ordinary shares (**Shares**) (**Rights Offer**) and advises that the following Shares have been issued:

- 12,148,549 Shares, being the acceptance of entitlements and additional Shares subscribed for under the Rights Offer; and
- 4,452,557 Shares, being the shortfall shares from the Rights Offer.

Mustera now has 116,226,221 Shares on issue.
