## QUARTERLY ACTIVITIES REPORT FOR 31 MARCH 2023

Mustera Property Group Ltd (**Mustera** or the **Company**) is pleased to provide an update on its operational activities during the March 2023 Quarter (the **Quarter**).

## HIGHLIGHTS

- 1. Mustera continued with its sales and marketing campaign for the Company's flagship project, Forbes Residences (Forbes or the Project).
- 2. The Company secured \$4.1m in apartment sales during the Quarter for the Project.
- 3. Construction has progressed on the Project with the structure now complete.
- 4. The Company's McCabe Street project in North Fremantle received development approval in March.

#### 1. Forbes Residences, 10 Forbes Road, Applecross

During the Quarter, construction reached an important milestone on the Company's flagship Project, Forbes Residences. The building has "topped out" with structure now complete. Internal fit out has commenced for the apartments, window installation is complete up to Level 5 and stud walls progressed up to Level 8.

In addition to the construction activities the Company continued with its sales and marketing campaign for the Project. The Company sold 2 apartments which has secured an additional \$4.1m in sales during the Quarter for the Project.

### 2. 15 McCabe Street, North Fremantle

During the Quarter the Company received development approval for the North Fremantle project from the Joint Development Assessment Panel<sup>1</sup>.

The project includes 42 residential (with one, two, three and four-bedroom) apartments over 8 storeys with panoramic views to Rocky Bay, Fremantle and Leighton Beach.
